In accordance with Rule 26, plaintiff has been trying to keep discovery focused tightly on claims and defenses, but it is apparent from UT's motion to compel and related filings that the parties have different visions about the scope of discovery; in particular, as it relates to UT's RFPs Nos 6, 7, 13 and 29. We are hopeful that Judge Howell will place reasonable limits on discovery, but in the event UT's vision of broad discovery about Lowery's private communications wins the day, plaintiff will be serving defendants with additional RFPs, seeking further communications from key players in this case.
