## **VIRTUAL PHONE BANK**

US Campaign for Palestinian Right

Students, teachers, and parents: make calls to your representatives in congress to urge them to support the Ceasefire Now resolution. You can do this every day, not just on November 9. The U.S. Campaign for Palestinian Rights (USCPR) has a tool that will call your phone and patch you through to your representatives. Leave a message with each of them.

- **Get others to join you:** throughout the week, <u>get the word out</u> to trusted members of your school community to get more people involved in the Day of Action and multiply the impact.
- A <u>Zoom room</u> will be open from 9:00 AM 3:00 PM on November 9. If you have access to a computer and want to connect with others, join that room while you make your calls. You can also get support there.
- 1. <u>Fill out this form</u> to let us know you're taking part. That allows us to keep track of actions & coordinate.
- 2. <u>Connect to the Virtual Phone Bank via Zoom</u> so you can make your calls in community with others.

### SCRIPT FOR SENATORS

I am asking the Senator to publicly call for a ceasefire, in line with the Ceasefire Now resolution in the House led by Rep. Cori Bush.

Any more military funding to Israel will fuel violence by arming the Israeli government. This is a genocide of Palestinian people in Gaza. The Senator must take action now to stop genocide and end all U.S. complicity in Israel's violence.

### SCRIPT FOR HOUSE REPRESENTATIVES

## STUDENT WALK-OUT

High school students are organizing walkouts on Thursday, November 9 in solidarity with the people of Gaza to demand a ceasefire, end to U.S. aid for Israel's genocide of Palestinian people, and call on local leaders to support Palestinian, Arab, Muslim and ALL students against hateful attacks here in the US.

NOTE: school walk-outs from across the city will come together at 3:00 PM in Bryant Park to join workers & college students for the SHUT IT DOWN FOR PALESTINE RALLY. See you there!

### STUDENT WALK-OUT CHECKLIST

Fill out this form to let us know you're planning a walk-out. That allows us to keep track & coordinate.

- Assess your school climate
  - What do you have to do to convince your administrators (you do not need their permission but it helps)?
  - Are there students that you can convince to walk out with you? What support would you need to convince them?
  - Do you expect counter protestors at your school?
  - Are there other collectives in your school like SAYA, Global Kids, Eco Club etc. that you can engage or convince to take action with you?
  - Make an assessment of the level of engagement you expect (number of students/parents that you are able to mobilize for the walkout because that influences the impact that you can have.)

### Assess your neighborhood

- Do you expect counter protestors around your school?
- Do you expect the community around your school to be receptive of the walkout?
- Make a note of the NYPD precincts nearby and the presence of police in or around the school.
- Find the route that gets you close to a guarantee of maximizing support and minimizing resistance.
- If you and your peers do not feel comfortable leaving your school, you could also march through the hallways and gather in central spaces in the school (or on the school steps) to do a sit in.

### Assess preparedness

- Have people been identified to take on different roles:
  - Elect <u>Speaker(s)</u>
  - Elect Chant leaders (2 per school)
  - Elect a <u>Social Media Coordinator</u> (posting using hashtags: #schools4ceasefire #shutitdown4palestine)
    - The SMC + Documentation Person should ensure all participants have masks to hide their faces, for anyone who doesn't want to be identified on camera
  - Documentation person
  - <u>Students Rights Coordinator</u> (print and distribute KYR flyers and getting people to keep NLG number on them)

### Identify Walkout + March Plan

- Identify exit/location in school where folks are gathering
- Identify route on map based on your assessment of neighborhood(where can people gather safely that is not too physically straining because folks also have a rally after)
- If the march is between 15-30 minutes then identify needs(water, bathroom, breaks for students that need it etc.)
- Backup meeting location( in case things do not work out as planned folks should know where the fallback meeting point is ).
- Safety Plan
  - Do people know their rights as student protestors?(Student rights coordinator)
  - 2 Marshal for every 15 students participating in the walkout and 1 for every additional 15 students.
    (TU)
  - Identify one of the Marshals to be police liaison. (focus on deescalation. We do not want all the walkouts to be tainted because one of our folks engaged and confronted a counter protestor.)
  - March route should be simple so it can be conveyed to people earlier on thus reducing the likeliness of folks being separated.
  - Marshals to make assessments of whether to block traffic or wait for traffic lights at intersections.
  - Marshals to make sure folks stay on the sidewalk and do not get on the streets.
  - Legal observers to deescalate with police.

### Engaging other students

- Start a conversation ("have you heard about the student walkout for Palestine on Thursday?"), get a sense for where they're at.
  - Are they enthusiastic? Great! Share the time, place, and reason you're walking out. Ask them directly: "will you join the walkout on Thursday at [time]?", "will you help us get the word out?"
  - If they seem uninterested/unsure: tell them that students all over NYC are planning walkouts on Thursday to demand a ceasefire in Gaza. Share your own personal reason for participating in the walkout. Ask them directly "will you join us for the walkout?"
  - If they are opposed: tell them to have a nice day and move on to the next person. If someone is staunchly opposed, it's unlikely you'll change their mind in one conversation. Focus your time instead on reachout out to students who are more likely to join you.

- Try to be patient with people who might not know (or care about) what's going on. Sharing your own personal reason for why you are participating in the walkout can be a great way to move someone else to take action.
- Get the word out at your school: print out flyers to hand around at lunch (get your friends to help).
- Accept and acknowledge that not everybody you speak to has access to the spaces you do and might be conditioned by what they see or hear (propaganda).
- Believe in your own power as a student organizer/activist to impact change.

### SAMPLE WALK-OUT PLAN

- Start at 11:30 EST.
- Be organizing beforehand, get student activists and your friends ready and coordinated.
- You can begin the walkout by standing up and beginning a chat. Meet up in the halls.
- Leave the halls of your school within 10-15 mins of starting, and mobilize outside!
- Begin chanting and hold space outside the school! If reporters show up, you can speak with them and use our talking points below.
- End at Bryant Park by 3:00 PM on Thursday to join the school walkout contingent of the SHUT IT DOWN FOR PALESTINE RALLY. Think about what trains you'll need to take to get there.

### TALKING POINTS

• You can refer to these <u>TALKING POINTS</u> when speaking to the media or mobilizing others. Use the messages that resonate with you, or use them as inspiration to create your own.

### **STUDENT DEMANDS**

- We stand against the brutal bombardment of besieged Gaza, to demand an immediate ceasefire, and to break the silence on Palestine at our schools.
- We refuse to stay silent when entire Palestinian families are getting massacred and millions are getting forcibly displaced from their homes.
- Defend and protect Palestinian, Arab and Muslim, and all students and our teachers against an increase in hateful, and racist rhetoric and attacks.

Post photos of your action on social media, and get others to do the same. Tag your Congress representatives with the hashtag #Schools4Ceasefire and #ShutItDown4Palestine to make sure they know about your action.

**MAKE SIGNS.** Get together with other students during a lunch break to make signs for your walk-out. You can also see a folder of <u>PROTEST SIGNS</u> here and print some out. **CREATE A FLYER.** To help get the word out, create a flyer to promote your action. We have a folder of **DESIGN ELEMENTS & TEMPLATES** you can use to create an Instagram post or flyers to print out. **Practice Chants.** To make sure people hear student's demand for ceasefire and end to U.S aid to genocide in Gaza, practice these <u>CHANTS</u> and use them for your walkout.

## DRAFT A STATEMENT/RESOLUTION

As a parent or educator, you can work with your **Community Education Council (CEC)**, **Parent Association**, **Parent Teacher Association (PTA)**, **School Leadership Team (SLT)**, **UFT Chapter**, or other group to pass a resolution or draft a sign-on letter in support of a ceasefire, an end to U.S. funding of genocide, and an end to Israel's occupation of Palestine. See below for samples and guidance to support you to pass a resolution or statement. <u>Fill out this form</u> to let us know you plan to write a statement.

## **Districts with progressive CECs:**

If yes, work with your CEC to pass a resolution that supports:

- Immediate ceasefire;
- An end to U.S. funding of the on-going genocide of the Palestinian people;
- An end to the occupation of Palestine; and
- Standing for justice and with\_all students, families, and school workers against antisemitism, anti-Muslim racism and Islamophobia

## **Districts with less progressive CECs:**

Consider drafting a sign on letter from school Parent Associations, Parent Teacher Associations, or School Leadership Teams that supports:

- Immediate ceasefire;
- An end to U.S. funding of the on-going genocide of the Palestinian people;
- An end to the Israeli occupation of Palestine; and
- Standing for justice and with all students, families, and school workers and against antisemitism, anti-Muslim racism and Islamophobia

What else you can do:

- Identify and get the support of elected leaders in your school district to to help sway your CEC;
- Partner with progressive teachers and community organizations to host a conversation or teach-in for your school, neighborhood, or district community.

### SAMPLE RESOLUTIONS / STATEMENTS

- Parents and educators in District 3 released a statement calling on their CEC to immediately rescind its harmful resolution of October 17, 2023.
- <u>Parents and educators in District 15 released a statement</u> in support of a ceasefire and an end to U.S. support for genocide on November 7, 2023.

## **KNOW YOUR RIGHTS**

### YOUR RIGHTS AS A STUDENT PROTESTER

Can students who participate in a walkout be punished for leaving class? Yes. If your school normally does not allow you to leave the building without permission, then you do not have any special right to do so to engage in a political demonstration. But, just because the school is authorized to punish you does not mean they must do so. It is worth asking for leniency.

**<u>READ MORE</u>** on your rights to protest in school.

You have the constitutional right to freedom of speech & expression in public schools. <u>Click here</u> to learn more about your rights at school.

What other tools can you use to organize in your school? You know best who the cool teachers are in your school. Make them your allies! Ask for time during class to talk to the other students and get them involved.

Can students be punished more severely for participating in a walkout rather than leaving for other reasons? No. Imposing harsher punishment on students who skip school to engage in political activities than on those who cut school for any other reason violates the First Amendment. If you believe this happened to you, <u>contact NYCLU</u> so they can gather more information. <u>PRINTABLE "KNOW YOUR RIGHTS" FLYERS</u>

What if you want to give out leaflets or make speeches etc, outside your school? Do you have to leave the area like the security guards tell you? NO! Anyone, including students, has the right to engage in peaceful First Amendment activity – including leafleting, petitioning, and picketing – on public sidewalks in front of schools in New York City.

### YOUR RIGHTS AS AN EDUCATOR: CIVIC ENGAGEMENT AND POLITICAL ACTIVITIES

Per **Chancellor's Regulations D- 130**, "school buildings are not public forums for purposes of community or political expression." **DOE's general policy** is that "students should learn in a politically neutral environment; employees should refrain from advancing their own personal political views while on school grounds; and, that schools and employees should avoid the impression that the school is endorsing any particular political perspective or point of view." School staff should be cautious not to use school facilities, equipment or supplies to promote political activities, or appear to solicit, direct, or compel students or other staff to participate in political speech, events, or activities.

**Per Chancellor's Regulation C-110**, staff may not participate in walkout, protest, demonstration, etc. during their scheduled work hours, including during lunch periods and breaks, or engage in political activity that causes them to be absent during the hours they are scheduled to work; however, staff can absolutely participate in political activities on their own time and not on DOE property.

### YOUR RIGHTS AS AN EDUCATOR: CONTRACTUALLY PROTECTED ACTIVITIES

- Schools can facilitate discussions and engage students in activities related to current events and civic engagement. Discussions and activities should include multiple points of view and be linked to relevant classroom activities, lesson plans, curriculum, etc.
- School staff can display posters, signs, etc. to the extent connected to classroom activities, lesson plans, curriculum, etc.
- Schools can develop safety plans as needed to ensure the safety of students participating in known organized walkout, protest, demonstration, etc. activities. Staff can volunteer to assist with such safety plans.

### YOUR RIGHTS AS AN EDUCATOR: SOME THINGS TO BE MINDFUL OF...

- Schools cannot organize field trips to participate in organized walkouts, protests, demonstrations, etc., stage their own such events, and/or distribute flyers promoting or inviting participation in such events.
- Schools CANNOT PREVENT STUDENTS FROM PARTICIPATING in walkouts, protests, demonstrations, etc; however, to ensure their safety, elementary school students must be signed out by a parent or guardian if they wish to participate.
- Schools should follow their regular <u>attendance policies</u> in determining whether any absences are excused or unexcused (including retaining proper documentation). There are no disciplinary consequences for excused absences.
- If the family communicates that a student is absent due to a non-school-sponsored event by verbal or written notice, reason code 34 (SPECIAL EVENT-EXCUSED ABSENCE) can be used.

If you should be arrested for any reason, contact your <u>UFT district representative</u>, who will contact the UFT's central office for assistance. You must also notify your principal and the Office of Personnel Investigations at <u>OPIarrestnotification@schools.nyc.gov</u> (see Chancellor's Regulation C-105).

You can request free legal support from Palestine Legal, which works with a network of organizations, attorneys, and advocacy groups to respond to requests for legal and advocacy assistance, and to document incidents of suppression. You may also find <u>these resources</u> related to doxing, your right to organize, and other common issues helpful.

### HOW EDUCATORS CAN SUPPORT STUDENTS TO PROTEST

While students have a right to free expression, the school can limit or punish them for their behavior if it creates a "substantial disruption or material interference in school activities." In most districts, a walkout would be a substantial disruption and probably a violation of the code of conduct (missing class, roaming in the hallways, etc.). A teacher can not protect a student from being disciplined by admin for engaging in a walkout, but they can **show support for their students by making classroom level decisions like canceling tests or major paper deadlines or making the lesson more flexible to accommodate students who walk out.**
