**ORDER GRANTING RECONSIDERATION**

Yes on 2 for Better Elections asked the Alaska Public Offices Commission to clarify the Final Order issued on June 21, 2021. Yes on 2 explains that the order concluded that Alaska Policy Forum violated the law but did not explicitly order it to comply with Alaska’s campaign finance laws. The Commission deems Yes on 2’s motion a request for reconsideration, grants reconsideration,<sup>1</sup> and modifies the order as attached to make explicit that Alaska Policy Forum should comply with the law within 30 days of the issuance of the modified final order.

The attached Final Order on Reconsideration, which replaces the Final Order issued on June 21, 2021, may be appealed to the superior court within 30 days from the date of the Final Order on Reconsideration.<sup>2</sup> A request for the Commission to reconsider the Final Order on Reconsideration must be filed within 15 days from the date the order
